## EMERGENCY UNEMPLOYMENT COMPENSATION (EUC) EXPIRATION NOTIFICATION

Dear Customer:

The Unemployment Insurance Agency (UIA) strives to keep you informed of changes to ensure that you understand how you will be affected. The purpose of this notification is to advise you that, under federal law, entitlement to all EUC benefits will end week ending December 28, 2013. This means that the last payable week for all tiers of EUC is week ending December 28, 2013, regardless of the number of remaining weeks of payment on your EUC claim.

***Please note that this letter was created to inform you of changes to the federal EUC program. It is not a determination of eligibility for unemployment benefits.***
