Dear Acting Secretary Cochran,

I write to request that the U.S. Department of Health and Human Services (HHS) take action to prevent several "midnight regulations" finalized by the Trump Administration from causing undue harm to Americans who rely on vital HHS programs or to stakeholders currently providing care.

The outgoing Administration published several final HHS regulations in the Federal Register in recent weeks with effective dates that have not yet taken effect. These final regulations, among other provisions, would promote discrimination against LGBTQ+ people and other minorities, upend the agency's regulatory review process, and undermine key provisions of the Affordable Care Act. In expressing its opposition to many of these regulations, the Committee on Ways and Means outlined its concerns both to the substance of such regulations as well as the manner in which these policies were hastily finalized.¹

I appreciate the memorandum issued yesterday by White House Chief of Staff Ronald Klain directing federal agencies to impose a regulatory freeze pending review, and for regulations recently issued that have yet to take effect, to "consider postponing the rules' effective dates for 60 days . . ." The incoming Administration deserves the

ability to assess these significant regulatory changes before their effective dates. Moreover, by rushing to finalize these regulations, the previous Administration did not allow sufficient time for stakeholder consultation. Accordingly, I urge you to act immediately to delay the effective dates of such midnight regulations so that the incoming Administration can identify the best course of action to amend or rescind these regulations as needed to prevent harmful policies from going into effect.

I look forward to working collaboratively with HHS in this Congress to enhance the health and well-being of all Americans, and to promote equity in our nation's health and human services systems.

Thank you for your prompt attention to this critical matter.
