Dear Acting Commissioner Bessent,

We write today regarding substantial delays in federal retirement processing for Internal Revenue Service (IRS) employees. Our offices are hearing from constituents who participated in the Deferred Resignation Program 2.0 (DRP) and have not received their annual leave or annuity payments. According to reports, DRP guaranteed fully paid administrative leave for employees until September 30, 2025, and introduced Voluntary Early Retirement Authority (VERA). Thus, employees near retirement age could retire earlier with full benefits.

*Tax Notes* reported that, as of early December 2025, the IRS had a backlog of 7,300 retirement applications.<sup>1</sup> Further, former IRS employees have a wait of between six to nine months before individuals receive their first annuity payment.<sup>2</sup> Traditionally, after retiring, IRS employees receive their final paycheck and annual leave within a few weeks. The delay in processing and payouts has caused suffering and real financial hardship.<sup>3</sup> Given the above, please provide written responses to the following by February 17, 2026:

1. How many IRS employees took the DRP?
2. How many retirement applications have IRS employees submitted since January 20, 2025?



3. What is the average wait time for employees to start receiving their first annuity after an application has been submitted?
4. How many retirement applications have been reviewed by the IRS to date?
5. What is the current backlog of retirement applications waiting for review by the IRS?
6. What was the backlog of retirement applications at the IRS on December 31, 2025?
7. How many retirement applications have been approved by the IRS and are pending at Office of Personnel Management (OPM)?
8. How long, on average, does it take the IRS to review and approve a retirement application?
9. How many IRS employees (by full-time equivalents) are reviewing these retirement applications?
10. When does the IRS expect to finish reviewing applications in the backlog submitted on or after January 20, 2025?
11. Since September 30, 2025, have employees who participated in the DRP received any money while their retirement applications are pending? If so, how many employees?
12. Is there an expedited review process for employees experiencing financial hardship? If not, why?
