Re: Food and Agriculture Organization Support for Currency Legislation - support for Chairman's Mark

Dear Mr. Chairman:

We originated this letter prior to the appearance of your *Chairman's Amendment in the Nature of a Substitute to H.R. 2378.* The signatories support that Amendment. The full prior letter is reprinted below as it was sent to the following representatives previously on this date: Levin, Camp, C. Peterson, Lucas, Pelosi, Hoyer, Van Hollen, Boehner, and Cantor.

The undersigned organizations represent agricultural producers, the people who actually grow the products and the raise livestock that end up in our food supply as well as in a wide range of processed and manufactured goods. We urge passage of legislation to counter the persistent misalignment of currencies.

Free and fair trade cannot exist in markets distorted by persistent currency misalignment. Undervalued currencies such as the Chinese renminbi impose a hidden tax on America's agricultural exports and force our farmers and ranchers to compete with subsidized products in our own and world markets.

We are disturbed that some are using statistics on our agriculture trade performance to argue against legislation to enforce agreed international norms of fair trade. Our agricultural trade performance is substantially hampered by the lack of enforcement and lack of reciprocity in the trade relationship with China and other countries. Agriculture is harmed, not helped, by failure to enforce the rules. In truth, while America's agriculture has remained in net export status, it has largely declined the last 20 years and we continue to perform well below our potential.

China's state-managed capitalism poses a particular problem for some U.S. agricultural producers. Rather than becoming the large and growing export market for all U.S. agriculture that had been expected after it was awarded permanent trade relations status and joined the World Trade Organization ten years ago, China can and does systematically expand its export of targeted agricultural products, such as apples, tomatoes, and seafood to name just a few.

China uses the same industrial policy techniques in agriculture as it does in manufactured goods. The state provides massive subsidies to develop an industry, plies it with cheap credit, interferes with import competition, and subsidizes exports. An undervalued currency is a central part of this beggar-thy-neighbor policy.

Counteracting the currency subsidy on imported goods will not by itself correct the problem. It is, nonetheless, an indispensable first step toward a solution. We therefore strongly urge you and every other member of the House to pass effective legislation to deal with this mercantilist challenge to American agriculture.
